Sub: - Aptitude test for the selection of visitors for the assessment of ASU colleges for the academic year 2025-26. - reg.

Sir/Madam,

With reference to the subject mentioned above, it has been decided in the 117th Board meeting of MARBISM that an aptitude test shall be conducted for the selection of visitors for the assessment of ASU colleges for the academic year 2025-26. Those who attend and qualify in the aptitude test only shall be considered as a visitor.

Rules of the aptitude test:-

1. A mock test (IRC) shall be conducted on 08.2.2025 for all the candidates, the instructions of which shall be communicated to their respective email id's.
2. The aptitude test shall be conducted on **10.02.2025 from 03:00 PM to 04:30 PM.**
3. The test shall be conducted on the online platform under web camera surveillance.
4. First half an hour shall be for the launch of the assessment and the duration of the actual test in one hour.
5. There shall be 50 multiple choice questions out of which 20 questions will be related to Minimum requirements and standards, 20 questions will be related to general aptitude and 10 questions will be related to technical skill.
6. There shall be no negative marks for any wrong answers.

Instructions for the candidates: -

1. The eligible teachers who have been recommended through the portal by the head of the institution are eligible for the test. However, addition or deletion of the teachers from the list is the discretion of the Board.
2. Such recommended teachers shall be intimated individually through mail regarding their eligibility.
3. The link for the test will be shared 01 day prior to day of the test.
4. The eligible candidates are required to attend the test by joining the link with their laptop/desktop.
5. The eligible candidates are required to switch on their webcam throughout the period of the test.
6. The test shall automatically end after the expiration of the allotted time.
7. The candidates shall ensure uninterrupted network connectivity to avoid any interruptions during the test.

The, detailed instructions to the candidates on how to navigate through the aptitude test and Software/System Specifications for candidate login are enclosed with this letter.
