To honor him on this special occasion, we are thrilled to announce the “Clinical Case Presentation Competition,” created exclusively for Ayurveda doctors.

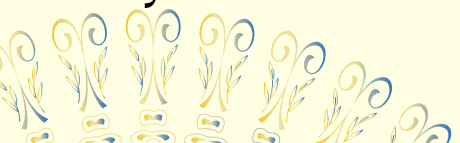
This competition aims to provide a platform for sharing and discussing successful case management strategies, showcasing clinical expertise, and furthering the growth of Ayurveda as a scientific and evidence-based healing system.

These competitions offer unique opportunities to share, discuss, and advance knowledge in the field of Ayurveda.

#### **Eligibility:**

Open to all qualified Ayurveda doctors with experience in clinical practice (Exclusively for practitioners who have completed BAMS within the last 15 years)

Participants are allowed to submit only one case, and it should be the one they have directly managed and treated themselves.



## Competition Guidelines



### Submission Requirements:

A comprehensive presentation of a clinical case, including case history, diagnostic investigations, both Ayurveda and modern diagnoses, treatment plan, and outcome, along with copies of all original case and investigation documents.

Emphasis on Ayurveda principles, treatment modalities (such as Panchakarma, Rasayana, herbal formulations), and their integration with modern practices are important.

Soft copy of BAMS degree certificate.

### Presentation Format:

#### 1. Case Selection:

Participants can submit interesting or challenging clinical cases they have encountered during their practice. These cases often involve rare diseases, complex diagnoses, or unique treatment challenges.

#### 2. Presentation Structure:

**Introduction:** Brief patient background (age, gender, presenting complaint).

**Clinical History:** Detailed history of the illness, including symptoms, family history, and relevant medical/social history.

**Examinations:** Physical examination findings and any abnormal findings.

**Investigations:** Lab results, imaging studies, and other diagnostic tests.

**Ayurveda Diagnosis:** Based on Ayurveda methods (e.g., Prakriti, Vikriti, Dosha imbalances)

**Modern diagnosis:** Formulation of a differential diagnosis followed by the final diagnosis.

**Management:** Explanation of Ayurveda treatment options, decision-making process, and the treatment plan implemented.

**Outcome and Follow-up:** The patient's progress and any challenges faced during the treatment course.

#### 3. Evidence-Based Approach:

Participants are expected to base their presentation on Ayurveda textual evidences, also if possible referring to the latest clinical guidelines, research, or clinical trials relevant to the case.

#### 4. Problem-Solving:

A crucial aspect is the approach to solving complex clinical problems, including how the clinician arrived at the correct diagnosis and managed the case. This could involve multidisciplinary approaches, rare diagnoses, or innovative treatments.



## Selection Process

### Initial Round:

Case submissions will be evaluated based on relevance, depth, and originality.

The first round will consist of a blinded review of the submitted case details, abstracts, and supporting documents.

From the submissions, 5 best cases will be selected for the in-person final oral presentation with the power-point slides

A minimum of 25 entries is required for the competition to proceed with the selection of the top 5 finalists.

### Final Round:

Only the top 5 selected cases will be invited for the final oral presentations before a jury panel and the audience.

Time Limit: 8 minutes per presentation, followed by a 2 minutes Q&A session.

### Judging Criteria:

- Clinical relevance and depth in understanding of Ayurveda.
- Innovative approach and treatment planning.
- Evidence of patient outcomes and efficacy of Ayurveda treatment.
- Clarity, structure, and professionalism in the submission & presentation.
- Only cases diagnosed & treated in the last two years will be considered.

This competition serves as a remarkable opportunity to engage with like-minded professionals, share your insights, and enhance your clinical practice. We look forward to your participation in this exciting opportunity to showcase the excellence of Ayurveda in clinical practice!

#### First and Second Prize Winners:

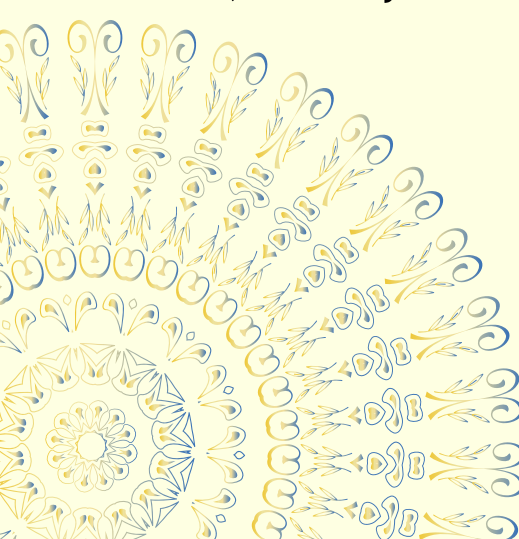
Winners will receive a cash award, memento, and certificate.
