### **Eligibility Criteria and Application Process**

Incomplete applications or those not endorsed by the competent authority will be rejected. Selection will be based on eligibility and availability of seats, and selected participants will be informed via email.

### **About the Institute**

The Central Ayurveda Research Institute (CARI), Bhubaneswar, is a peripheral research unit under the Central Council for Research in Ayurvedic Sciences (CCRAS), Ministry of Ayush, Government of India. The institute is dedicated to advanced clinical research in Ayurveda, with a special focus on hepatobiliary disorders.

CARI houses a well-equipped, NABH-accredited Ayurveda hospital comprising an

Outpatient Department (OPD), a 50-bedded Inpatient Department (IPD), modern clinical laboratories (Pathology and Biochemistry), and diagnostic facilities such as X-ray, ECG, and Bone Mineral Density (BMD) testing. It also includes a GMP-certified pharmacy and a Medico-Ethnobotanical Survey Department.

The institute has a DHR-registered Institutional Ethics Committee (IEC) to oversee ethical standards in clinical research. Over the years, CARI has conducted several clinical and collaborative research projects with premier national institutions including AIIMS, ICMR, and ICAR. It is also actively engaged in public health outreach initiatives such as SCSP, AMHCP, THCRP, and WCH across various regions of Odisha.

In alignment with the national vision of capacity building in AYUSH, the institute is being developed into a training hub. A dedicated training centre is under construction within its 3-acre campus. With support from the Ministry of Ayush, the institute has launched "Ayush-Diksha", an initiative to develop high-quality online course modules for practitioners, researchers, and academicians.

CARI regularly organizes Refresher Orientation Training Programmes (ROTPs), Continuing Medical Education (CME) programmes, workshops, seminars, health fairs, and short-term training courses for AYUSH professionals, academicians, and traditional healers. The

institute continues to play a key role in bridging traditional Ayurvedic wisdom with contemporary scientific practices through education, research, and community engagement.
