A- Introduction:

Online applications are invited from Indian Citizen for recruitment to the Post of Professor Kayachikitsa/Panchakarma under IPGAE&R at SVSP, Kolkata under Health & Family Welfare Department, Government of West Bengal.

D- Qualification as per recruitment rules:

(a) Method of Recruitment:

By promotion from the post of Reader/Associate Professor or Lecturer having requisite qualifications prescribed for direct recruitment to the post of Reader or Associate Professor except the qualification of age:

Provided that if any post remains vacant even after departmental promotion or on account of non availability of suitable candidates for promotion at any particular point of time such vacant posts shall be filled up by selection (direct recruitment) through the West Bengal Health Recruitment Board.

(b) Qualification for direct recruitment:

(I) Essential:

- (i) A degree in Ayurved from a University or its equivalent as recognized under the Indian Medicine Central Council Act,1970;
- (ii) A Post -Graduate qualification in the subject or speciality concerned included in the Schedule to the Indian Medicine Central Council Act, 1970, as amended time to time, from recognized University or Institute, established by law;
- (iii) Ten years' teaching experience in the subject out of which atleast Five years' teaching experience as Reader/Associate Professor or Ten years' teaching experience as Assistant Professor or Lecturer in the subject concerned wherever the post of Reader or Associate Professor does not exist;
- (iv) A minimum of four publications in recognized journals.

Note: Candidates must be registered in Part 'A' of the State Register of Ayurvedic Medical Practitioners maintained by the Paschim Banga Ayurved Parishad or in part-1 of the Central Register maintained by the Central Council of Indian Medicine.

N.B.:

1. Clarification of "its equivalent" means:- at present there is only one degree in Ayurveda i.e. BAMS (Bachelor

of Ayurvedic Medicine & Surgery) under the Indian Medicine Central Council Act, 1970.

- 2. Clarification of in the subject or speciality concerned means:- the subject in which a candidate holds a post graduate degree.
- 3. Clarification of Recognized journals means:- Peer-reviewed journal.
- 4. Clarification of in the concerned subject under experience section:- Here 'in the concerned subject' under experience section means the candidates having teaching experience in a particular speciality or department of Ayurveda.

E- Age:

Not more than 50 years on the 1st day of January of the year of advertisement. Upper age limit is relaxable for the persons having higher qualifications and/or longer experience than those prescribed. The age is also relaxable for the persons holding substantive appointment under the Government. Age shall be relaxable for the candidates belonging to the categories of Scheduled Caste, Scheduled Tribe or Other Backward Classes as per the Government rules or orders for the time being in force.

Note:

- The candidate whose age is within the prescribed limit as mentioned above and does not require any age relaxation should not fill up the field "Age relaxation" while filling up the online application form.
- For age proof, admit card or mark sheet or certificate of Secondary or Xth standard Examination or any Government ID Proof have to be submitted (which one contains the candidates name, Father's name & D.O.B. of the candidate).
- In case of married women, who are using their changed surname in the application as a result of marriage but who cannot produce documentary evidence in support of her changed surname, the following documents may be uploaded along with proof of D.O.B in a running PDF as detailed below.
- 1. Marriage registration certificate as a proof of marriage wherever possible.

F- FEE:

Money order, Cheque, Bank Draft, and Cash etc. shall not be accepted.

No application shall be considered unless accompanied by the requisite application fee excepting Candidates belonging to SC/ST category of West Bengal and persons with disabilities specified under Disabilities Rule, 1999 (certificates obtained before the Advertisement date) who do not require to pay any fee. Such exemption of fee is, however, not applicable to any OBC candidate.

No claim for refund of the fee shall be entertained nor shall it be held in reserved for any other examination.

- **A.** Candidates are requested to upload all years' Mark Sheets including supplementary mark sheets, if any, along with passed certificate of a degree in Ayurved from a University as recognized under the Indian Medicine Central Council Act, 1970, in the space provided for the same.
- **B.** The following documents must be uploaded as the proof of aforesaid qualification:
 - All years Mark sheets including supplementary mark sheets, if any of a degree in Ayurved from a University as recognized under the Indian Medicine Central Council Act, 1970 along with passed certificate.
 - Attempt/Chance Certificate: There is no separate field to upload attempt/chance certificate. Candidates need to upload it along with mark sheets and passed certificate of a degree in Ayurved from a University as recognized under the Indian Medicine Central Council Act, 1970.
