Vide subject and reference 4th cited above, it is to submit that, in continuation of the instructions from the Commissioner of Health and Family Welfare and Mission Director, NHM Telangana, Hyderabad has requested the Chairman, District Selection Committees of concerned District and accorded permission to fill up the vacant posts of Mid - Level Health Providers (MLHP)s as and when the vacancy arises in Ayushman Aarogya Mandirs (AAMs) on a Contract Basis under NHM as per the recruitment guidelines appended.

The details of the posts to be filled are as follows:

Further it is to submit that, the Commissioner of Health & Family Welfare and Mission Director, NHM, Telangana Hyderabad has issued specific recruitment guidelines for filling the vacant posts these guidelines which are enclosed here with for reference and necessary action.

**Guidelines for recruitment of MLHPs Vacancies on Contract basis
under National Health Mission**

1. Applications are invited for **Seven (07)** posts of Middle Level Health Providers (MLHPs) at Ayushman Aarogya Mandirs (AAM) under National Health Mission (NHM) to work under Medical and Health Department, Jangaon.
2. Applications are hereby invited by the Jangaon District Selection Committee headed by the Collector & District Magistrate Jangaon from the eligible applications to the vacant posts.

3. Age:

The minimum age is 18 years and the maximum age is 46 years in terms of G.O.Ms.No.30 dated 08-02-2024 of General Administration (Services-A) Department, Government of Telangana. The minimum and maximum age shall be reckoned as on 01.07.2025 with the following relaxations allowed for reckoning the maximum age limit as per rules in force:

- (a) For S.Cs., S.Ts & BCs & EWS Relaxation of (05) years.
- (b) For Ex-service men relaxation of (3) years and length of service in armed forces (applicable only for the posts of Medical Officers)
- (c) For NCC (who worked as Instructor in NCC) relaxation of (3) years and length of service in NCC
- (d) For Physically challenged persons relaxation of 10 (ten) years.

4. Method of Recruitment

Recruitment shall be done by the District Selection Committee on behalf of the concerned District Health Society, for all the vacant positions.

For the posts of MLHPs, the guidelines for recruitment issued by Commissioner of Health and FW & MD, NHM, TG, HYD in Lr.Rc.No.96/NUHM/HWC/NHM/2017, dated: 06.09.2022 shall be followed (For age the guidance issued at "3) Age "shall be followed).

5. Selection will be done on Merit Basis and based on the following criteria:

- (1) For MBBS/BAMS Candidates Selection will be made on Multi-Zone Basis i.e., Multi-Zone II.
- (2) For B.Sc (N)/G.N.M Candidates Selection will be made on Zonal Basis i.e., Zone-V (Nalgonda, Suryapet, Yadadri Bhuvanagiri, and Jangaon Districts).
- (3) Merit Lists shall be prepared separately for each of the categories of posts.
- (4) Merit list will be prepared based on the marks obtained with above criteria and displayed on Official website of the concerned District Collector, for transparency and also for calling objections.



(5) In the Health and Wellness Centres located in municipal areas, the positions will first be filled up with MBBS doctors as per eligibility. After exhausting the MBBS doctors, these vacancies will be filled with BAMS doctors as per eligibility.

(6) In the Health and Wellness Centers located in non-municipal areas the positions will first be filled up with MBBS doctors as per eligibility. After exhausting the MBBS doctors, these vacancies will be filled with BAMS doctors as per eligibility. If no doctors are available, then these positions can be filled up by Staff Nurses as per the eligibility.

(7) Selections list will be prepared from the finalized merit list duly following the Rule of Reservation (RoR) and Presidential Orders.

(8) The Selected candidates shall maintain the Headquarters.

(9) These positions are not transferable.

6. Rule of Reservation:

(i) Rule of Reservations in respect of Community, Disability, Ex-Service Men / Women shall be Strictly observed as ordered by the Government of Telangana from time to time.

(ii) 33 1/3% reservation for women will be applicable as per the orders issued by Government in G.O.Ms.No.3 Dept for Women, Children, Disabled & Sr.Citizens (Prog.I) dated 10.02.2024 and in GO.Ms.No.35, Genl. Admn. (Ser.D) Dept., dated 13.02.2024

(iii) The Rule of Reservations to local candidates is applicable as per the Presidential order.

(iv) The districts should continue the existing Roster.

(v) The vacancies for the posts mentioned in G.O.68, falling in Scheduled Areas should be filled exclusively with the Local Scheduled Tribes.

7. How to Apply:

i) Application forms along with instructions can be downloaded from the official web site of the District Collector, Jangaon District.

ii) Filled in application form shall be submitted in person or through registered post to the District Medical and Health Officer, Jangaon to which the candidate is applying. Applications which are received after due dates will be summarily rejected. District Selection Committee is not responsible for postal delays.

General Information to the candidates:

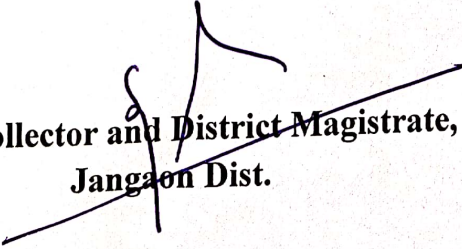
- 1) The District Collector reserves the right to change/modify/cancel the selection process at any time during the process and the decision of the District Collector will be final and binding.
- 2) The Mode of Appointment is on Contract basis for a period of 1 year or till the actual need ceases whichever is earlier.
- 3) No TA/DA will be paid to the candidates for attending the interviews.
- 4) Appointees will work under the overall administrative control of CH&FW and MD, NHM.
- 5) The termination notice shall be (30) days period from either side.
- 6) Candidates selected under Outsourcing mode shall be appointed through Outsourcing Agency.
- 7) The posts notified are not permanent/regular Government posts and purely temporary.
- 8) The Panel of Candidates will be utilized for future vacancies, until a period of one Year from the final date of Selection of Candidates, in this Notification.
- 9) The selected candidates will be intimated through email/official communication.
- 10) The selected candidates may have to perform tours.
- 11) Their performance will be evaluated from time to time and also the same will be considered Extension / Termination of their service, in case of future requirements.
- 12) The employment is subject to disciplinary rules and in case of any deviation, employment is liable for termination.

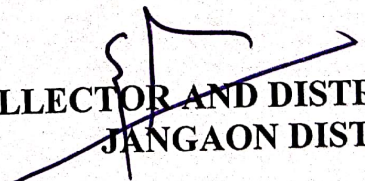
