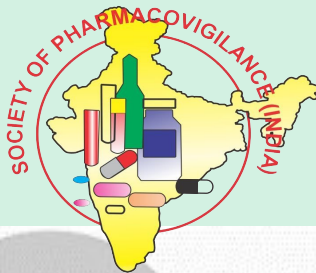

ABOUT PGIMER

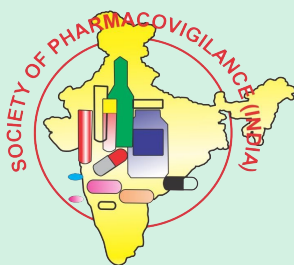
