

## CAREER OPPORTUNITIES AFTER B.A.M.S. BY DR SD

After completing B.A.M.S. (Bachelor of Ayurvedic Medicine and Surgery), graduates can pursue careers in government services, private healthcare, academics, research, management, manufacturing, and emerging healthcare sectors.

### 1. MEDICAL OFFICER

BAMS graduates are eligible for Medical Officer posts under various central government bodies, such as:
