**NOTICE FOR RECRUITMENT**

The State AYUSH Mission, Tripura (SAMT), is going to fill-up below mentioned different categories of posts on contractual basis from the interested candidates who are permanent resident of Tripura. The engagement will be initially for a period of 11 (eleven) months, which may be extended further within the project duration based on performance evaluation, with an intervening gap of at least one day. The details of the vacancies are as follows:-

**3. Date & time of submission of application through online mode:-**

The interested & eligible candidates are requested to submit application form as per prescribed format in the mail ID - [samtrecruitmentmedicos2026@gmail.com](mailto:samtrecruitmentmedicos2026@gmail.com) from 12:00 AM of 22<sup>nd</sup> May 2026 to 11:59 PM of 02<sup>nd</sup> June 2026.

- No application will be considered/ accepted before or after the above specified time frame.
- No application will be entertained in physical mode or by postal service etc. other than online mode i.e. submission of application form through e-mail specified above.

**4. Norms for submission of Application Form (API format) :-**

**A.** Interested candidates are requested to submit his/her application form (API Format) as per the prescribed format (Format Enclosed) and with all original documents (scanned), with one copy of recent Passport Size Color Photograph.

**B.** Self-attested softcopy (in PDF format) of the following documents needs to be submitted:  
 (a) Copies of qualification (Mark sheet) from Madhyamik onwards, (b) Valid Registration Certificate (c) Caste Certificate (for reserved categories), (d) Permanent Resident Certificate of Tripura (PRTC), (e) Age Proof (Madhyamik Admit Card)/ 10<sup>th</sup> Standard Board Admit Card), (f) Photo ID with address (Aadhar card/ Driving license/ Voter ID).(g) No-objection Certificate (if

applicable, as per API format) and Certificate of PH (if any).

**C. Applicants to make one single PDF file of API format & related documents as stated above & to send via email only at [samtrecruitmentmedicos2026@gmail.com](mailto:samtrecruitmentmedicos2026@gmail.com) . No applications shall be entertained other-than one single pdf file consisting duly filled API format along with all supporting documents.**

**5. Candidates' selection criteria:-**

• The candidates will be selected based on their merit on the basis of total marks obtained by the candidate. Total maximum score is 100 marks. Out of 100 marks, 50 marks based on Academic Performance Index (API) as per requirement of the qualification specified above for each post & 50 marks on viva-voce/ personality test for all the post.

**6. Norms for appearing the Walk-in-interview:-**

• Candidates will be requested to appear before the Interview Board along with all original documents as submitted during submission of application form along with the photocopy of API, submitted during applying for the post. The date, time & venue of walk-in-interview will be published on due course in the NHM, Tripura website only - <http://tripuranrhm.gov.in/job.html>

**7. Age limit:-**

• 40 years for UR candidates & 45 years for SC/ST/PH candidates for all categories of posts as on 31.12.2025.

**Instructions:**

- 1. Interested candidates applying for the multiple posts (if any), shall mentioned in the application forms i.e. API format mentioning in the specified area. No separate applications will be entertained for applying in the multiple posts.**
2. Vacancies shall be subject to the State Reservation Policy of Tripura. Horizontal reservation for women in the posts shall be applicable as per the policy notified by the State Government.
3. Only those candidates having the Permanent Resident Certificate of Tripura (PRTC), issued by the Govt. of Tripura shall be eligible.
4. In the case of CGPA/ GPA, applicants shall provide marks details in percentage at the time of filling the form and documentary proof for the basis of calculation of percentage shall be produced whenever it is required. If the applicant fails to present the above supporting documents, he/she shall be liable for the disqualification/ cancellation of his/her candidature.
5. T.A. & D.A. will not be admissible for appearing in the recruitment procedure.

6. The selected candidates will have to perform their duties for a minimum of 06 to 08 hours in a day and may have to serve in any part of the State of Tripura.
7. If at any stage of recruitment, it is found that the candidate does not fulfil the eligibility criteria and/or that she/ he has furnished incorrect/ false information/ certificate/ documents or has suppressed any material fact(s), his/her candidature shall stand cancelled, apart from taking actions as per legal provisions.
8. The decision of the competent authority of the State AYUSH Mission, Tripura in any matter relating to the recruitment at any stage of the recruitment process will be final and binding upon the candidate.
9. Any candidate against whom a criminal case is pending in any court or has been convicted by any court, such candidates are barred from applying in the above posts.
10. The Mission Director, National Ayush Mission, Tripura shall have the right to suspend/ cancel any application/ entire recruitment process or a part thereof any time without showing any reason.
11. The Mission Director, National Ayush Mission, Tripura reserves the right to amend recruitment rules and process at any time of the selection. Any such amendment shall be valid and binding on the candidates during the recruitment process.
12. Any legal dispute pertaining to the recruitment process shall be under the jurisdiction of the courts in Agartala, Tripura.
13. Candidates already employed in any Govt./ Semi-Govt./Societies/ any other organization shall have to submit No Objection Certificate from their employer while applying for the post and have to produce release order/ resignation acceptance order from their concerned employers while joining in the above mentioned post, failing which his/her candidature will be cancelled and the next eligible candidate will be selected for filling up the vacant post.
14. Issuance of No objection certificate to any official employed with the State Health and Family Welfare Society, Tripura, Tripura State Health Protection Society or State Ayush Mission, Tripura, shall be considered subject to fulfilling eligibility conditions prescribed for issuing No Objection; and in the event of their selection/recruitment, they shall have to resign from their current service and to submit resignation acceptance order before joining the post.
15. The number of post may increase / decrease at any point of time during the recruitment procedure or even the entire recruitment process may be cancelled anytime without assigning any reason.
16. The engagement will initially be for 11 (eleven) months which may further be extended

- based on performance till project period, subject to an intervening gap of at least one day.
17. Only a full-time course for the essential qualifications as required in the Eligibility Criteria shall be considered valid.
