- Status: All positions are on a consolidated remuneration basis and purely on contract basis.
- Registration with Delhi Bhartiya Chikitsa Parishad/ Board of Homoeopathic System Delhi is mandatory in case of BAMS/BUMS/BHMS doctors

2. Mode of Selection:

Selection will be made on the basis of document verification and Interview.
