2. The candidates will be engaged against different programmes of the Council and duties will be assigned accordingly, including field duties.
3. The candidate should have working knowledge of computer programmes such as MS-Office, Internet and e-mail, etc., as he/she may be required to work independently.
4. The selection will be made for the Clinical Research Unit for Homoeopathy, Tirupati as indicated in this advertisement. Once posted, the candidate will not normally be transferred. However, the Council reserves the right to transfer candidates to any other Institutes/Units of the Council.
5. The Council will prepare a panel of candidates and offer engagement as and when vacancy/need arises. The number of vacancies may increase or decrease as per requirement.
6. The eligibility of the candidate will be determined as on the date of interview.
7. The competent authority reserves the right to postpone/cancel the recruitment exercise at any stage.
