Payment of T.A:

- a) All transaction will be made only by electronic transfer through banks.
- b) No amount will be paid to trainees except the reimbursement of travelling expenses, that too on actual basis as per the rules subject to selling.
- c) Payment of T.A should be made only at the end of the training programme after obtaining full attendance as per admissibility or actual, whichever is less.
- d) Places where connected by rail will be reimbursed with actual fare limited to AC 2 tier or actual claim, whichever is less.
